Notification No. Shiksha-II-Chha 5P-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "VED DHARA EDUCATION, Regd. - 15 That the name of the affiliating Board of the institution should be mentioned in the prospectus with Approval No. Registration No. And Affiliation No. the same should also be displayed on the notice boards of the institutions, at least 2-3 places visible easily to all.
- 16 That the Society will provide the facility of provident fund as per the EPF norms to its staff and will take up welfare programme for the employees and students as well.
- 17 That the Manager shall, within six months after the end of the every Academic year, submit to the competent authority the report of Chartered Accountant on the Audit of the Accounts under sub-section (1).
- 18 That the concerned school will also not charge fee towards Building fund, Infrastructure fund and development fund etc. from the students/parents.
